IT IS UNDERSTOOD THAT THE MODIFICATIONS, RENOVATIONS, AND PROJECT MAY NOT:

1. Interfere with, or obstruct any easements on your property or adjoining property.
2. Damage landscaping on your property, or that of a neighbor.
3. Have any effect of any kind on Common Elements.
4. Cause a nuisance or interfere with the peace or privacy of anybody in the community.
5. Cause any person in the community to be affected by undue noise, garbage, or dust.
6. Be performed by an unlicensed contractor or without the permits required from all governmental agencies.
7. Take an unreasonable period of time to complete.

The homeowner is responsible for all damages and repairs arising from, or having any connection with, the project. The HOA may place a lien upon the homeowner's property for payment of any damages and repairs arising from the project. Upon approval of your project by the HOA, the work must commence within forty-five days and be completed within a reasonable time. Failure to commence work within 45 days will require submission of a new application and new approval before work may then commence.
